Subject: Salt Pan Land Management System (SPLMS), a pivotal GIS web-based portal of Salt Commissioner's Organization (SCO) for efficiently overseeing the extensive salt pan lands-reg.

The undersigned is directed to refer to the subject mentioned above and to convey that the Salt Commissioner Organization(SCO), an attached office of the Department for Promotion of Industry and Internal Trade (DPIIT) of the Ministry of Commerce & Industry holds charge for managing about 60,000 acres of salt land (SCO land) across nine States of India, i.e. Tamil Nadu, Andhra Pradesh, Odisha, West Bengal, Maharashtra, Gujarat, Karnataka, Haryana and Himachal Pradesh.

2. Department for Promotion of Industry and Internal Trade (DPIIT) has received several requests from various entities, including Central Government Ministries/Departments, State Governments, and Central & State Public Sector Enterprises, seeking transfer of Government owned land, administered by the Salt Commissioner's Organization.
3. On approval of the Cabinet, the Internal Policy Guidelines for transfer of salt pan lands owned by the Government of India through SCO, at places other than Mumbai and its Suburbs, for public purpose, was formulated by DPIIT vide OM No. 04011/10/2020-Salt dated 24th January, 2012 (copy enclosed). It is important to note that a nominal fee of Re.1/- (Rupee one only) is applicable for the transfer of land to Central Government Ministries/Departments, as per Rule 279 (2) of the General Financial Rules.
4. As a strategic initiative and in order to facilitate the transfer, this Department has developed the Salt Pan Land Management System (SPLMS), a pivotal GIS web-based application. This system is designed with the objective of efficiently overseeing the extensive salt pan lands administered by the Salt Commissioner Organization (SCO), encompassing approximately 60,000 acres of salt land across nine States.
5. The portal is equipped with a comprehensive land records database to facilitate effective record-keeping. It comprises diverse layers, incorporating satellite and drone image as well as information on infrastructure networks e.g. Highways, Railways, Ports, Airports, Industrial

Parks, Coastal Regulation Zone (CRZ), and the Master Plan and Development Pan of Land use of concerned states. These layers enable precise proximity analysis of SCO lands.

6. Central Ministries/Departments will be granted access credentials to this portal enabling them to explore salt land parcels of interest and commence discussions regarding the acquisition of such lands from DPIIT.

7. For the above purpose, it is requested to designate a Nodal Officer under your Ministry/Department and provide contact details to facilitate communication and seamless coordination of the land transfer process and associated activities with the DPIIT.
