In this regard, NESTS (National Education Society for Tribal Students) has already issued letter dated 14-09-2022 and 23-09-2022 to certain state governments and 10-01-2023 (Enclosed) to all the Construction Agencies (PSUs) to take Electrical & Water Supply connection in the name of Nodal Officer, State EMRS Society. 
