Sir/madam

This is regarding letter on under refence on the subject cited above. In this regard, all the construction agencies are requested to kindly submit their claims as per the following guidelines:

- i) CAs are directed to strictly ensure quality of works as per terms and conditions of the MoU.
- ii) CA shall ensure to conduct TQPA as per agreement and TPQA reports alongwith compliances should immediately be submitted to the Construction Quality Assurance Cell of the NESTS for evaluation by the Cell.
- iii) In case, CA receives any interest on such advance the same shall be credited to the NESTS. CA also ensure that there shall be no diversion of funds.
- iv) The following documents shall be submitted for the claim of deposit
 - a. Letter for demand of advance fund
 - b. Utilization Certificate cum Progress report similar like used in CPWD (Sample attached) (Annexure-I)
 - Detail of payments released to the contractors and copy of last cash voucher alongwith Component wise detail of work done for which payment released. (Annexure-II)
 - d. Undertaking for statuary compliances as submitted earlier. (Annexure-III)
 - e. Component wise sufficient number geo-tagged photographs, clear and from different angles with clearly mentioning name of the component on the photos. (Annexure-IV)
 - f. Copy of e-GST invoices issued for the works (Annexure-V)
 - g. Status of Extension of Time from NESTS (wherever applicable) (Annexure-VI)
 - h. Copies of deviation/variations approved (if any) (Annexure-VII)
