Sub.: Regarding issuance of Form-III from the Principal Employer to the Contractor for obtaining labor license.

Dear Sir/Madam,

Kind attention is invited towards the subject cited above.

2. In this context, following clauses of various Acts/Rules, Forms, etc are reproduced:

Contract Labour (Regulation and Abolition) Act, 1970:

Clause 2- Definitions. "Principal employer" means-

(iv) in any other establishment, any person responsible for the supervision and control of the establishment.

Clause 20- Liability of principal employer in certain cases-

1. If any amenity required to be provided under Section 16, Section 17, Section 18 or Section 19 for the benefit of the contract labour employed in an establishment is not provided by the contractor within the time prescribed therefore, such amenity shall be provided by the principal employer within such time as may be prescribed.

2. All expenses incurred by the <u>principal employer</u> in providing the amenity may be recovered by the principal employer from the contractor either by deduction from any amount payable to the contractor under any contract or as a debt payable by the contractor.

Clause 21- Responsibility for payment of wages.-

- (1) A contractor shall be responsible for payment of wages to each worker employed by him as contract labour and such wages shall be paid before the expiry of such period as may be prescribed.
- (2) Every <u>principal employer</u> shall nominate a representative duly authorised by him to be present at the time of disbursement of wages by the contractor and it shall be the duty of such representative to certify the amounts paid as wages in such manner as may be prescribed.
- (3) It shall be the duty of the contractor to ensure the disbursement of wages in the presence of the authorised representative of the principal employer.
- (4) In case the contractor fails to make payment of wages within the prescribed period or makes short payment, then the principal employer shall be liable to make payment of wages in full or the unpaid



balance due, as the case may be, to the contract labour employed by the contractor and recover the amount so paid from the contractor either by deduction from any amount payable to the contractor any contract as a debt payable by the contractor.

Clause 29- Registers and other records to be maintained. -

- (1) Every <u>principal employer</u> and every contractor shall maintain such registers and records giving such particulars of contract labour employed, the nature of work performed by the contract labour, the rates of wages paid to the contract labour and such other particulars in such form as may be prescribed.
- (2) Every <u>principal employer</u> and every contractor shall keep exhibited in such manner as may be prescribed within the premises of the establishment where the contract labour is employed, notices in the prescribed form containing particulars about the hours of work, nature of duty and such other information as may be prescribed.

Chapter- VI- Wages (of THE CONTRACT LABOUR (REGULATION AND ABOLITION) CENTRAL RULES, 1971:

- 72- The <u>principal employer</u> shall ensure the presence of his authorized representative at the place and time of disbursement of wages by the contractor to workmen and it shall be the duty of the contractor to ensure the disbursement of wages in the presence of such authorised representative.
- 73- The <u>authorised representative</u> of the <u>principal employer</u> shall record under his signature a certificate at the end of the entries in the Register of Wages or the ¹³[Register of Wage-cum-Muster Roll], as the case may be, in the following form:

Certified that the amount shown in column No has been paid to the workman concerned in my presence on ... at ...

Chapter-VII-REGISTERS AND RECORDS AND COLLECTION OF STATISTICS.

- 74- Registers of contractors- Every principal employer shall maintain in respect of each registered establishment a register of contractors in Form XII.
- 78- Muster Roll, Wages Register, Deduction Register and Overtime Register.-
- (c) Every contractor shall obtain the signature or thumb-impression of the worker concerned against the entries relating to him on the Register of Wages or Muster Roll-cum-Wages Register, as the case may be, and the entries shall be authenticated by the initials of the contractor or his authorised representatives and shall also be duly certified by the authorised representative of the <u>principal</u> <u>employer</u> in the manner provided in Rule 73.
- 81- (3) Every <u>principal employer</u> shall, within fifteen days of the commencement or completion of each contract work under each contractor, submit a return to the Inspector, appointed under Section 28 of the Act, intimating the actual dates of the commencement or, as the case may be, completion of such contract work, in Form VI-B.]
- **82- Returns**.- (2) Every <u>principal employer</u> of a registered establishment shall send annually a return in Form XXV (in duplicate) so as to reach the Registering Officer concerned not later than the 15th February following the end of the year to which it relates.

- 3. NESTS has not engaged the Contractor directly. Therefore, NESTS is not in a position to mention in the Form III that it has engaged the Contractor.
- 4. Every Contract Agreement between PSU and Contractor has clause/s vide which contractor has to submit register of payment of wages to the Engineer-in-Charge every month twice for verification of the wages paid. It is unfeasible for NESTS to check/control/supervise/monitor/review, etc details of the wages paid by the Contractor to the labourers employed/engaged at the site.
- 5. From the excerpts of the various Acts/Rules/Forms mentioned above, it has been made clear that NESTS cannot be the Principal Employer. PSU has directly engaged the Contractor. It has direct control on the site for supervision/maintenance of labour registers along with taking care of the grievances of the labourers engaged/employed at the site. It can also act in case of default of the contractor. Thus, PSU shall be the Principal Employer.

In view of the above stated position, any request to NESTS, in future or pending at present, regarding issuance of Form-III from the Principal Employer to the Contractor for obtaining labor license shall not be entertained. And Form-III Issued earlier in the above context to be treated as null & void.
