Sir/ Madam,

Kind attention is invited towards the letter of even no. dated 21.04.2022 (encl.).

In this regard, as approved by Competent Authority the paragraph no. 3- *“Wherever, DPR is approved, the expenditure towards shifting of HT/LT Poles..... The PSU/Construction Agencies shall submit the proposal to NESTS in this regard.”* is replaced with following directions:

“Wherever, DPR is approved, the expenditure towards shifting of HT/LT Poles..... The PSU/Construction Agencies shall submit the proposal to NESTS in this regard, if the estimated cost is Rs 10 Lakhs or more. For the expenditure below Rs 10 Lakh, Competent Authority of PSU shall accord the approval on their own with an intimation to NESTS. The bills in respect of such expenditure shall be claimed in Running Account Bills of Works”

Sub: Construction of Ekalavya Model Residential School (EMRS)- Shifting of HT Poles/Lines reg.

Dear Madam/Sir,


During Scrutiny of Land Suitability, it is observed that there are HT/LT poles/lines passing through the land in 10 to 15% cases in almost all the States. The States has also requested to release the payment for shifting of HT/LT poles/lines. Such Proposals received from Odisha, Chhattisgarh, Meghalaya and Jharkhand State. The construction Agencies has also raised the issues and difficulty in construction due to pending shifting of HT/LT Lines/Poles.

In view of the above, with the approval of competent authority, following procedure is henceforth adopted.

1. The expenditure towards shifting of LT/HT Lines shall be charged to project estimate and same shall be made part of DPR (Detailed Project Report) within the approved A/A & E/S.
2. Wherever, DPR is approved, the expenditure towards shifting of HT/LT Poles may be charged to the project estimate (already sanctioned) on case-to-case basis provided adequate fund is available and the total project cost does not exceed the approved A/A & E/S. The PSU/Construction Agencies shall submit the proposal to NESTS in this regard.
3. The payment to the concerned Department/Electricity Company shall be made only when it is ensured that the land is demarcated and is free from all encumbrance (no forest issue & no any other hindrance to commence the work) as well as the contractor is in place to start work.
