With reference to the subject cited above, this is to inform that Ekalavya Model Residential Schools (EMRSs) have been sanctioned by the Ministry of Tribal Affairs, Govt of India across the country for providing quality modern education to the tribal children. This is a flagship program of the Ministry of Tribal Affairs under which 87 new EMRSs have been sanctioned in the state of Odisha.

As you may be aware that Hindustan Steelworks Construction Ltd. (HSCL) has been assigned the task of construction of 40 new EMRSs across various districts of the State. This has reference to the execution of the captioned subject and letters mentioned above. In this connection we would like to invite your kind attention that, clarification regarding power supply to the construction site and installation of transformer is yet to be provided. Please be informed that, most of EMRS projects, awarded to us, are on the verge of completion. But electricity power supply to the project buildings are yet to be obtained. The remaining portion of work shall be completed after power supply is provided to the sites.

As per the extant guidelines the beneficiary shall have to enter into a bipartite agreement with TPNODL (the power supply agency) before the electricity supply is effected. Based on HSCL's request, NESTS vide their letter referred at SI. 2 has intimated that Nodal Officer/State EMRS society shall be treated as beneficiary/party and authorize to carry out agreement with electricity supply agency. (Copy Enclosed). But appropriate action regarding the same is yet to be taken.

In view of the above we once again request you to kindly take up the matter with concern nodal officer/state govt. authority for arrangement of electricity supply to the construction sites. Our working agencies are waiting to complete the projects after the power supply to the project sites.

Dear Sir,

This is with relation to power supply arrangement to ongoing EMRS projects. We are undertaking the process of execution of this project at 24 locations spanning over 5 districts of the state of Odisha. We require following clarifications / policy provisions concerning power supply to these sites by TATA Power.

1. Which agency/ authority shall supply incoming power from the source station to the transformers?

2. In order to obtain power supply permission, the beneficiary (s) shall have to enter into an agreement with TATA Power person for which documents like Aadhar, PAN of that person is required. In the present context, who shall be treated as the party to the agreement with the electricity supply agency i.e TATA Power?

We request you to kindly clarify the above points urgently as EMRS/ Koliana and EMRS/Baripada sites are in advanced stage of completion. Your guidelines shall be followed with respect to other sites as well.

Early response in this regard is highly solicited.

As you aware that Eklavya Model Residential schools (EMRSs) are being constructed in different parts/blocks of Odisha state. The task of construction of 40 EMRSs has been assigned to HSCL (A Govt of India Undertaking) at different locations.

Vide letter under reference, Zonal Head of HSCL Odisha informed that construction of EMRSs at 24 locations is in progress and requested to issue further directions regarding provisions of power supply from the source to the transformer of said sites. Copy of said letter referred at (1) is also attached herewith for ready reference.

In aforesaid matter, it is pertinent to mention that as per EMRS Guidelines clause 9.2 (b) State government has to Provide, or cause to be provided, electricity, water and other utility services at substantially concessional rates at EMRS.

In the above context, this is to inform that Nodal Officer, State EMRS Society shall be treated as beneficiary/party and authorize to carry out agreement with electricity supply agency.

In view of the above, you are requested to look into the matter and issue further necessary directions to all the concerned.
