Madam/Sir,

As you are aware that the construction activities of EMRS are either taking place or the construction work at various locations has already been commenced in most of the State. As per para 3.6 of MoU signed between the Construction Agency(s) and NESTS it is specifically mentioned that "Construction Agency shall be fully responsible for quality, technical/ structural soundness and effective & efficient construction management of the work" to be executed for construction of EMRSs on PMC basis.

Furthermore, para 2.7 of the agreement state that "the Construction Agency shall nominate full time regular technically qualified and experienced engineers at each site for supervision, monitoring and execution of the project in a time bound manner". In this regard, you are requested to provide the following information immediately to this office.

1. The Minimum Quality Plans to be observed for construction of EMRSs including detailed list of mandatory tests on construction materials as prescribed in CPWD specifications and BIS Code of practice.
2. List of engineers deployed or to be deployed for supervision, monitoring and execution of each project as per clause 2.7 of the agreement.
