Dear Madam/ Sir,

With reference to the allotted EMRS sites as per reference as mentioned above, it may be noted that the process of allotment of land in favour of EMRS, taking possession of land, and demarcation of land is in progress for many EMRS locations.

There are instances reported that in many places, the construction agencies have started pre- construction and construction activities without any formal communication of sanctioning of the particular EMRS from NESTS. It may be noted that allotment of a site to a construction agency and formal sanction of the school after fulfilling all procedural requirements like ensuring availability of suitable land are different processes altogether.

As the documents such as sanction order of State Government, land deed, gift deed, survey map, land use certificate etc are awaited from the State Governments in a lot of cases in-spite of regular follow up by this office, you are requested to liaise with the local administration in getting the land sanctioned in the name of the school, its suitability as per the checklist circulated and submit these details to NESTS in respect of sites allotted to you. Based on the documents

received, NESTSwill issue the formal sanction orders for the concerned EMRS at the particular site and thereafter commencement of pre-construction activities and construction activities can only be taken up by the construction agency.

In view of the above the construction agencies are requested to coordinate with the local administration and concerned revenue authority for ensuring the above formalities and submit them to NESTS for issuing the sanction order. It is reiterated that the construction agencies can commence the pre-construction and construction related activities in the allocated locations only after the receipt of formal approval from NESTS.



Guidelines for Essential Components required in an EMRS

2.1 General Points:

- a. The below mentioned guidelines are indicative only. School building norms specified in the NBC, CBSE & NVS shall be followed in respect of construction project across the country in plains as well as hilly, North Eastern & LWE affected.
- b. All the stipulations provided for in the **Access India Campaign for Divyang Students** to be ensured.
- c. All the fixtures & fitment to be used for construction of EMRS (Schools, Hostels, Other facilities & Staff residences) must be off Standard quality conforming to Bureau of Indian Standard (BIS) without fail.
- d. The schedule of rates for undertaking the construction shall be as per CPWD norms subject to the overall ceiling for construction of EMRS & EMDBS in plains as well as hilly & LWE areas.
- e. **Escalation on account of delay**. The NESTS would like to impress upon, construction agencies to complete all the pending construction works in a pre-approved fixed schedule so that there is no further cost escalation.
- f. The land for construction of School shall be provided by the concern State Government. The land should be free of all encumbrances.
