Any admissible expenditure over and above the said ceiling limit shall be met from the operational expenditure of the respective schools.

The verified list of EMRS principals must be mailed to NESTS by 11th July, 2024 in the format given at *Annexure-II* and (share in excel format also). Further, all the nominated principals may kindly be informed to plan their visits as per designated dates.
