### Policy for Release of funds under Grant-in-Aid - General

#### to State/UT EMRS Societies

# Rationale for change in procedure for disbursement of GIA Fund to State/UT EMRS Societies

In order to streamline disbursement of the Grant-in-Aid fund to State/UT EMRS Societies on half yearly basis, it is informed that information and data shall be submitted by State Societies on half yearly basis. It is also desired that information and data should be submitted through Communication Module of MIS portal of EMRS. State/UT EMRS Societies are duly conversant with the use of said module. Any information not received through Communication Module of MIS would not be considered.

#### Procedure:

In view of above, State/UT EMRS societies are requested to prepare the budget estimate for FY 2024-25 based on actual requirement of funds. State Societies shall submit the fund demand as per the below: -

- State Societies shall assess the annual demand in the beginning of every Financial Year.
- The Estimated Annual Expenditure may be worked out as per **Annexure I**. The Estimated Annual Expenditure may also be bifurcated on a half yearly basis.
- The demand calculated as per Annexure I & II will be submitted by the state societies on half yearly basis through the correspondence module. The timeline for submitting the half yearly demand is as follows: -

- While submitting requirement of funds, State Societies will submit the latest fund
  utilisation status so as to assess the balance unutilised GIA fund lying in the hands of
  State/UT EMRS Societies as per Annexure II.
- Total number of schools & students' enrolment mentioned in fund demand should be matched as per MIS Portal. In case any difference least of students numbers shall be considered for release of funds under recurring head.
- Information and data must be provided through Communication Module of MIS
  portal of EMRS. Any demand received otherwise physically or on email shall not be
  entertained.

State/UT Society shall submit the information in component-wise format (shall follow revised detailed recurring-cost guidelines send vide letter no. NESTS/Finance/EMRSSocietiesFinance/160/2021-22 dated 15.11.2022).
