Subject: -- Initiating education and tutoring through DTH platform for EMRS students-reg.

Sir/Madam,

With reference to the above subject, it is stated that NESTS in collaboration with CIET is initiating start of DTH TV channel exclusively for EMRS students spanning from Class 9th to 12th, offering telecast of contents applicable for curriculum (aligned with NCERT's syllabus and textbooks) and preparation of IIT/NEET/CLAT etc.

In addition to the above, NESTS has decided that the official start of this dedicated channel may be in the last week of May 2024. Accordingly, state society is requested to ensure the availability of all the required infrastructure involved in the smooth execution of the telecast on the dedicated channel. For ready reference, the list of basic infrastructure and important tasks to be done before 15th May, 2024 is given below:

- a) All the schools shall have proper functional DTH system with set top box to telecast the free to air channel.
- b) Ensure availability of the high-speed internet (upto 100Mbps) in every school, if it is not available.
- c) All schools shall have at-least 01 functional Smart TV (65 inch) in place and if the school has functional Smart Boards, then same shall be calibrated and connected with DTH & set top box, so as to ensure live streaming through Smart boards.
- d) All schools shall have email and phone number which shall be dedicated to respective EMRSs.

In this regard, the state society is requested to kindly direct the concerned EMRS principals or the concerned officers, accountable for it to ensure the availability of the above enlisted resources before 15/05/2024 and it is suggested that funds for centralized activity may utilized for the purpose.
