Subject: - Manthan Shivir organised by the Ministry of Tribal Affairs with States on July 18-19, in New Delhi-reg.

Dear Sir.

As you may be aware that a two-day long Manthan Shivir had been organised by the Ministry of Tribal Affairs with States to undertake Progress-Review of Schemes, and deliberate on Vision 2047 and 100-days Action Plan of the Ministry, on July 18-19, in New Delhi. During the said Shivir, recommendations have been made by States for enhancing the construction quality and faster delivery of EMRS.

As per the said recommendations, following is intimated for necessary action:

- a. Being the Chairperson of District Level EMRS Construction Management Committee, it is requested to ensure the establishment of requisite laboratories at the construction site/s for checking the quality of materials used in the construction of EMRS.
- b. Block Level EMRS Construction Management Committees (BLCMCs) may be constituted at the earliest to supervise critical indicators of EMRS construction at the ground-level, so that the construction quality is enhanced and faster delivery of EMRS is ensured. The officials, as under, from concerned Block wherein EMRS construction is being done shall become part of BLCMCs:
- 1. Block Development Officer-Chairperson.
- 2. Assistant Engineer or equivalent of State PWD-Member.
- 3. Assistant Engineer or equivalent of PHED/Zilla Panchayat/RES-Member.
- 4. Assistant Engineer or equivalent of State Electricity Department-Member.
- Deputy Superintendent of Police-Member.
- Sarpanch & Panchayat representatives of concerned village/s of Block wherein EMRS construction is taking place- Members.
- Assistant Conservator of Forest- Member.
 (only in those case/s where forest related hindrance issues are being faced)
- 8. Block Tribal/Social Welfare Officer- Member Secretary.

The committee is expected to attend to the same points in so far as their block are concerned as given out in OM dated 18.08.2023 (encl.) for District Construction Management Committees.

Since, EMRS could be inaugurated by highest dignitary from Central/State level, it is urged that a regular monthly review with the Chairperson of Block Committees may be taken at the district level till schools are handed over/inaugurated & made functional.

Subject: Constitution of EMRS District Construction Management Committee

The National Education Society for Tribal Students (NESTS), Ministry of Tribal Affairs, Government of India is establishing Eklavya Model Residential Schools in blocks with significant tribal population. More than 400 new schools are being constructed, whereas more than 200 existing EMRSs are being renovated. It is therefore necessary that the District Administration supervises some critical indicators so that the construction/ renovation of EMRSs is smooth and meaningful.

The following district level committee is constituted for the purpose.

The Committee is expected to attend to the following points.

- The location of EMRS should be connected with all-weather road.
- ii) The EMRS site must be provided reliable safe and adequate drinking water through Jal-Jeevan connection.
- iii) Adequate provision of encumbrance-free and clearly demarcated land, with Forest Conservation Act clearances, where needed, should be ensured.
- Local issues of law and order should be addressed so that construction work is not obstructed.
- Any issue related to quality of new construction or of existing building infrastructure, furniture, etc. should be urgently brought to the notice of NESTS.
- vi) Connectivity of reliable and required power supply should be ensured.
- vii) Any other important matter, such as afforestation in the EMRS campus, landscaping, telecom connectivity, etc. will also be supervised with the help of officers concerned in the District.
