Notice

1. NESTS is in receipt of various references regarding the TA/DA entitlement/rates and procedure for reimbursement of TA/DA for employees recruited and posted by NESTS. In this regard, a clarification was already issued by NESTS vide letter no. NESTS/H-1/47/HRMiscellaneous/2024-25 dated 06.12.2024. Copy of the letter is enclosed herewith. It is again clarified that TA/DA entitlement for employees recruited and posted by NESTS shall be as per the TA rules issued by Ministry of Finance vide OM No. 19030/1/2017-E.IV dated 13.07.2017.
2. TA/DA bills below the level of Principal shall be approved and passed by Principal or Principal Incharge (Where the post of Principal is Vacant). In case of Principal or Principal Incharge (Where the post of Principal is Vacant), the TA/DA bills shall be approved and passed by the state society. Permission to engage personnel is already allowed vide letter mentioned at S.No.1.
3. On approval of competent authority as per S.no. 2, payment will be released by the respective EMRS from the Operational Expenditure component of recurring grant.
4. TA/DA entitlement of Employees/Staff of posted/engaged by State Societies shall be governed by the rules of respective State Societies and the same shall be approved and passed as per the existing procedure of the respective state.

- Sub: 1. Allotment of duties to consultants who are posted on contract by NESTS**
2. Pre-audit of TA / DA bills of Principals and In-charge Principals by State Society
3. Acceptance of resignations of employees other than the post of Principal.

Kind attention is requested about the subject cited. The following guidelines are communicated with the approval of the Competent Authority.

1. NESTS is posting Consultants on contract basis to assist the State Societies for effective monitoring and managing the EMRSs of the concerned State / UT. The posted Consultants will act as Liaisoning Officer between NESTS, State Society and EMRSs of the State Concerned. The services of posted Consultants are at the disposal of NESTS which will be used for coordination with State Societies and EMRSs.
2. Clarifications are being sought regarding Pre-audit of TA / DA bills of Principals and In-charge Principals. In this regard, it is clarified that Principal / In-charge Principal may pass the TA / DA bills of all the staff other than the self whereas the same in respect of Principal / In-charge Principal is to be pre-audited by the State Societies for which personnel may be engaged by you, if required.
3. As per the guidelines of NESTS, only State EMRS Societies have been empowered to accept the resignation of employees other than the post of Principal. The power shall not be delegated to any other officials of States

This issues with the approval of Competent Authority.
