In inviting reference to the notified Revised Disciplinary / Appellate and Reviewing Authority for all posts of NESTS vide letter No. NESTS/H-1/58/Policy/2024-25 dated $23^{\rm rd}$ December 2024 (available at S. No. 76 of Circulars list of NESTS Hqrs in Website), the following are clarified: -
