Subject: Advisory to EMRSs and State EMRS Societies on Excluding Children of Staff/Doctors/Paramedical Personnel from Recurring Fund Demands to NESTS – AY 2025–26

Madam/Sir,

As per the EMRS Admission Guidelines for the Academic Year 2025–26, issued on 02.01.2025, and in line with the decisions of the 15th Governing Body Meeting of NESTS, it has been clarified under Point 2.3 (Reservations in Admission) that:

Children of the following categories serving in the **same block** where the EMRS is located are eligible for admission under specific provisions:

- Staff of EMRSs and Centre of Excellence for Sports,
- Doctors and paramedical staff of Government Hospitals.

Therefore, it is important to note that:

- These children shall **not be considered part of the EMRS Scheme**. Only education is provided free of cost.
- Wards of Staff of EMRSs and Centre of Excellence for Sports, Doctors and paramedical staff of Government Hospitals are admitted as day scholars only. Only when they represent the school in sports meet/cultural fest etc, the expenditure is borne by EMRS.
- Accordingly, no additional financial implications are to be borne by the EMRSs, NESTS, or the Ministry of Tribal Affairs (MoTA) for their admission or continued stay.
- 2. Further, EMRSs and State EMRS Societies are advised not to include these students while submitting recurring fund demands to NESTS, as their expenses are not covered under the EMRS Scheme.

This issues with the approval of the competent authority.
