**Subject: Proposed modification for the priority allotment of accommodation to the staff of EMRSs – reg.**

Representations are being received from the Physical Education Teachers (PETs) of Eklayva Model Residential Schools (EMRSs) requesting for priority allotment of accommodation in EMRSs. By considering the physical presence of PETs to conduct morning PT from 5.30 am to 6.15 am and evening games from 4.30 pm to 5.30 pm in addition to their regular classroom transactions on all working days, the request of priority allotment of accommodation to PETs has been considered by the Competent Authority and the revised order of priority is as under: -

S. No.	Proposed modification
1.	Principal
2.	Vice Principal
3.	Hostel Warden (Female)
4.	Hostel Warden (Male)
5.	Staff Nurse (Female) – Essential staff on outsourcing – Share accommodation
6.	PGTs handling classes X and XII (To be nominated as House Masters)
7.	PwBD Staff on regular basis (Teachers to be nominated as House Masters)
8.	Physical Education Teachers (PETs)- To attend morning PT and evening games
9.	Mess Staff on regular basis (if mess is run by school itself).
10.	Rest of the staff (House Masters will be given priority).
11.	Driver and Electrician – Essential staff on outsourcing – Shared accommodation.

2. Rest of the terms and conditions mentioned vide letter No. NESTS/EMRS/Stateissues/100/2021-22 dated 9<sup>th</sup> October 2024 remain the same.
