Subject: Utilization of Funds for Procurement of Computers and Peripherals in Compliance with NESTS Letter No. NESTS-Circulars/129/2025-26 dated 20.11.2025 Sir/Madam.

With reference to the letter no. NESTS-Circulars/129/2025-26 dated 20.11.2025, wherein it has been decided that all functional EMRSs shall be equipped with a minimum of 30 functional computers along with necessary peripherals, on priority. Further, all schools having fewer than 30 functional computers have been directed to assess and identify the additional number of computers and UPS units required to meet this minimum standard.

- 2. In this regard, it is informed that the required procurement may be met from the Capital Expenditure component of the Recurring Cost. Furthermore, NESTS has empowered EMRS Principals to procure the required computers and peripherals. State EMRS Societies are requested to transfer the funds to the EMRSs for this purpose.
- 3. States/UTs that have already received funds under the Capital Expenditure component are advised to first fulfil the above requirement of ensuring at least 30 functional computers in each EMRS, and only thereafter utilize the remaining funds for other capital procurements.
- 4. States/UTs that have not yet demanded funds for this purpose are requested to conduct a gap analysis to identify the number of additional computers and UPS units required, and submit their fund demand to NESTS on or before 10.12.2025, to enable timely allocation and procurement.
- 5. Further, any shortfall of funds under the Capital Expenditure component may be met from the State Administrative Expenditure component of the Recurring Cost.

To All Principals Eklavya Model Residential Schools (EMRSs)

Subject: Procurement of Computers and Peripherals for EMRSs - reg.

Sir/Madam,

It has been observed that several EMRSs are facing a shortage of computers and related peripherals, which is adversely affecting the implementation of digital learning in schools.

- In this regard, it has been decided that all functional EMRSs shall be equipped with 2. a minimum of 30 functional computers along with necessary peripherals on priority. Schools having fewer than 30 functional computers are directed to identify the number of additional computers and UPS units required to meet this minimum standard.
- The respective Principals are hereby empowered to procure the required computers 3. and peripherals through the GeM portal, strictly as per the specifications issued by NESTS (Annexure-I). Necessary hardware and software support must be ensured at the time of procurement. Schools shall procure only good-quality, branded computers; purchase of assembled or refurbished systems is strictly prohibited.
- Further, NESTS is in the process of creating GeM IDs for all EMRSs. All Principals 4. are requested to share the requisite details as sought vide NESTS letter dated 04/11/2025, to facilitate timely completion of this process.
