Subject:- One-Time Declaration on Statutory Deductions in regard to electricity expenses, and furniture/kitchen equipment-reg.

Sir,

As a matter of policy, a One-time declaration is sought from the Zonal Manager/s of PSUs in a state-wise manner regarding the applicability of statutory deductions i.e., Income Tax TDS, GST TDS and labour cess, if any in regard to *electricity expenses*, and furniture/kitchen equipment.

The declaration shall be forwarded through NESTS to concerned Escrow Banks. Thereafter, upon the basis of the said declaration concerned Escrow Banks shall release the funds to PSUs in regard to *electricity expenses*, and furniture/kitchen equipment after withholding the statutory deduction amount. The transfer of funds for the payment of statutory dues shall be done by concerned Escrow Banks to the relevant PSUs, preferably before the last working day of the bank. Statutory dues paid/payable by the construction agency before the issue of this policy shall also be covered under this amendment.
