Subject: Implementation of NESTS Group (Term) Insurance Scheme – 2024 and Submission of Nomination Forms.

Madam/Sir,

The NESTS Group (Term) Insurance Scheme – 2024 has been implemented with effect from 19.09.2025. As per the provisions of the scheme, it is mandatory for every employee to fill in the nomination form, which shall be duly placed in the respective service book. For the purpose of nomination, the definition of "Nominee" under the scheme is as follows:

Male (Married): Spouse, children, dependent parents, son's widow, and children.

Male (Unmarried): Dependent parents.

Female (Married): Spouse, children, dependent parents, dependent in-laws, son's widow, and children.

Female (Unmarried): Dependent parents.

Non-Family Nominee (Applicable only if no family exists): If a government servant does not have a family at the time of making the nomination, they may nominate any other person(s). However, if the government servant subsequently acquires a family (for example, upon marriage), the earlier nomination shall automatically become invalid, and a fresh nomination must be submitted in favour of eligible family member(s).

The prescribed proforma of the NESTS Group (Term) Insurance Scheme – 2024 Nomination Form is enclosed herewith for ready reference.

Principals are requested to ensure that the above instructions are brought to the notice of all employees under their control and that the nomination forms are obtained and placed in the service books without delay.
