NOTICE

NESTS notified for recruitment of teaching and non-teaching staff through ESSE-2025. Tier-I result has been published. Many representations are being received requesting for re-checking of result to confirm their declared score of the individuals concerned. It is noticed on verifying the representations that either the candidates are not calculating their marks (right/wrong answers) properly or calculating their result with wrong answer key. Therefore, considering the similar requests, it is notified that the candidates appeared in Tier-I examination of ESSE-2025 may apply for calculation sheet along with a copy of their attempted OMR sheet with the prescribed fee @Rs. 500/- per post on or before **07.03.2026**. Candidates who had sought clarifications including information under RTI or otherwise are also required to apply afresh for the calculation sheet along with the required fee. No other mode of requesting clarification will be entertained.

The prescribed fee is to be remitted to CBSE through Bank Draft in favour of **Secretary, CBSE payable at Delhi/New Delhi** issued by any of the scheduled banks. The candidates should mention their Roll No., Post applied for, Name & Address correctly in their application and enclose a copy of the ESSE-2025 admit card (Tier I). The Roll Number & Name should also be mentioned on the back side of the Bank Draft. The application should be sent by speed post or by hand only to **Director, CTET Unit, Central Board of Secondary Education, P.S. 1-2, I. P. Extension, Patparganj, Delhi - 110092** within the stipulated period, failing which no further correspondence will be entertained.

The calculation sheet shall be sent only on the registered e-mail id of the applicant, who had appeared for the Tier-I exam. The calculation sheet shall not be provided to any institution or school for display, commercial purpose or to print media. Application submitted on behalf of the candidate and the incomplete application will be summarily rejected without any further reference.

The decision of the Competent Authority of CBSE shall be final and binding on the candidates. However, no request will be entertained under any circumstances which will be received after **07.03.2026** in the office of CBSE.
