In continuation of notice dated 28.03.2025 regarding the format of Identity Cards for employees of Eklavya Model Residential Schools (EMRS), it is hereby informed that the design of the Identity Card has been slightly modified with the approval of the Competent Authority.

Accordingly, the revised format of the Identity Card along with the standardized lanyard design shall be adopted by all EMRS to ensure uniformity and standardization of employee identity cards across all EMRS institutions nationwide.

The following issuing authority shall continue to remain the same as specified in notice dated 28.03.2025:

1. For all staff other than the Principal/Principal In-charge:

The Identity Card shall be issued by the Principal/Principal In-charge of the concerned EMRS.

2. For Principal/Principal In-charge:

The Identity Card shall be issued at the EMRS Society level.

All EMRS are requested to strictly follow the revised format of the Identity Card and lanyard with immediate effect.

The approved format of the Identity Card and lanyard is enclosed for necessary compliance.

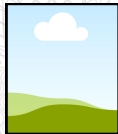

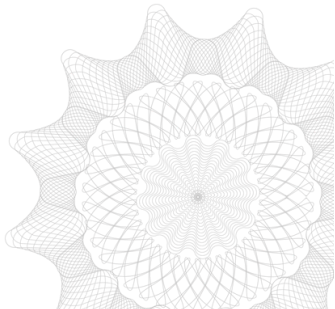
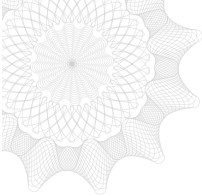
